The primary responsibilities will include advising on legal matters relating to programming for Virgin Media but also the provision of legal support to the TV3 Group on all platform, content commissioning agreements and acquisitions. The role holder will also be required to support the business on legal regulatory matters with a particular focus on telecommunications, data protection and broadcasting.

Specific Tasks/ Duties:

- The negotiation and drafting of carriage agreements, VOD agreements and app agreements with broadcasters and other rights holders. The role holder will be required to work closely with the legal programming team in Virgin Media UK and commercial programming leads in Ireland and the UK.
- Support the TV3 Group on the drafting and negotiation of programming commissions and acquisitions for all TV3 channels across a wide genre of programming.

- Support the TV3 Group on the drafting and negotiation of platform agreements where the TV3 channels and/or the TV3 Player are made available to third party platforms.
- Provide legal advice to the business on any new content related projects, including where required carrying out rights audits.
- Advise on legal matters in respect of privacy/data protection matters.
- Provide legal support on Regulatory matters with a particular focus on telecommunications, broadcasting and data protection matters, playing a lead role in any legal investigations.
- Provide legal advice to the marketing department on advertising and customer communications.
- Provide advice to senior stakeholders including at CEO and Senior Management level within the business on all of the above matters.

The Person:

We are seeking an individual with the following qualities:

- 4 years PQE.
- Strong background in commercial contracts with a particular focus on programming contracts, both linear and on demand and other IT and IP commercial contracts.
- Solid background and demonstrable experience in data protection and privacy laws
- Strong background in telecommunications, broadcasting and consumer protection law.
- Excellent negotiation, technical and drafting skills, with an exceptional ability to attend to detail.
